### **NEW BUSINESS:**

Landfill Manager Brian Austin informed the Refuse Board he will be bringing Jim Wilson back around March 16, 2020, depending on the weather and conditions at the landfill.

Landfill Manager Brian Austin informed the Refuse Board he purchased 11,500 gallons of dyed #2 diesel on March 5, 2020 for \$1.72436 per gallon. Total bill was \$19,952.50.

Discussion was held on purchasing gravel at the landfill. There was much discussion about purchasing gravel when the county has gravel. Landfill Manager Brian Austin informed the Refuse Board he will be needing 10 to 15 loads of gravel soon. The Refuse Board was given a price sheet from Fossum's Materials of the cost of gravel. It was decided the Refuse Board would discuss the matter with the Valley County Commissioners when the board went to discuss the fees at the landfill with the commissioners. Board Member Kari Lee Knierim stated the taxpayers are paying for gravel twice if the landfill purchases gravel from Fossum's Materials.

Secretary Schindler informed the board she figured out the cost of the yearly post-closure and closure payment:

Jon Kliewer moved to set tires fees by the cost to take the tire across the scale plus \$100.00 per tire for wrongful dumping in containers or container site. Glenn Guenther seconded the motion. Motion carried.

Kari Lee Knierim moved to assess repeat offenders double the fee after the second time of charging the repeat offender. Dan Carney seconded the motion. Motion carried.

Discussion was held on using the customer letter for education and advertisement on the changes to the landfill. Secretary Schindler received quotes: Free Trader - \$275.00 per edition for ½ Page Glasgow Courier - \$196.88 per edition for a 3-column ad BS Central - \$75.00 each time for ½ page ad Kari Lee Knierim moved to run the customer letter through April for the Free Trader and Glasgow Courier and once a week
