#### **NEW BUSINESS:**

Discussion was held on roll-off container hauling bid. The was only one bid opened on May 26, 2021, from T&R Trucking, Inc. The bid was rejected by the Commissioners. The next bid is to be opened on June 22, 2021, at 10:00 AM in the commissioner's office. There are two bids, one for two years and one for five years. Mr. Thompson from T&R Trucking, Inc. asked the Refuse Board if they planned on having the county do the roll-off container hauling themselves. Refuse Board stated it depended on what the bid came in at.

Discussion was held on the fiscal year 2021/2022 budget and finances. Refuse District Manager Brian Austin and Secretary Schindler showed a preliminary budget to the Refuse Board. It was decided to add a line item for the grinding of tires under expenditure and a line item for Frazer/Oswego Assessment and Charges under revenue. Some figures were changed under expenditure. Loans were discussed. There are two loans on the road. These loans will be done in the fiscal year 2021/2022. One loan for a scraper. This loan will be done fiscal year 2025/2026. One loan for a front wheel loader. This loan will be done fiscal year 2023/2024.

# Mary Armstrong moved to accept the finances. John Fahlgren seconded the motion. Motion carried.

Discussion was held on a CIP plan from Barry Damschen Consulting LLC. Mr. Damschen did not have the report ready at meeting time. He will have it ready for the next meeting in July.

Discussion was held on the investment account for Closure/Post Closure. There is a yearly payment for roughly \$17,000.00. The interest has covered this payment since 2009. The yearly payment this fiscal year brings the account to -2,982.23. In the past year's funds have been transferred from the regular account into the investment account.

Mary Armstrong moved to transfer \$50,000.00 into the investment account. John Fahlgren seconded the motion. Motion carried.

Discussion was held on assessments. Refuse Board has been going over the report Barry Damschen's Consulting on a new assessment system. More work needs to be done and questions to be answered before a decision can be made. The commissioners will talk to the Corps of Engineers about a tax bill coming from the county.
