Chairman John Rogenes called the meeting to order.

Chairman Rogenes asked for public comment.

Resident Robert Strand from Fort Peck did not like the wording on the signs at the container sites. He would like more clarification. Mr. Strand stated he is not driving to Glasgow for 3 small branches for example. Landfill Manager Brian Austin explained to him it is mostly using common sense. For instance, if you only have enough trash/debris to feel a small garbage can, nobody is going to say anything to the resident for putting that into a container. The Refuse Board is trying to stop the abuse of the containers: trailers, construction materials. large load of branches and yard debris, etc. Mr. Strand still feels the wording is not clear. Thanked the Refuse Board for their time and left the meeting.

Commissioner Tweten stated the commissioners have been reading past minutes from the refuse. In the past it looks like the Fort Peck tribes was charged for non-taxed housing. Commissioner Tweten stated an enterprise like the Refuse District can charge all entities. Secretary Schindler has check with Treasurer Brenda Anderson for past payments from the Fort Peck Tribe. Treasurer Anderson explained it would be hard to tell exactly what the payment was paid for or to find an A101 on payment going to far back without having and exact amount.

Glenn Guenther moved to investigate how many non-taxed houses there are and what the charge would be to the Fort Peck Tribe. Also looking into the cost to have T&R Trucking picking up the containers in a fiscal year for Frazer and Oswego. Myron Redfield seconded the motion.

Secretary Schindler could not find one and called Barry Damschen for some help. Mr. Damschen gave some numbers to call.
